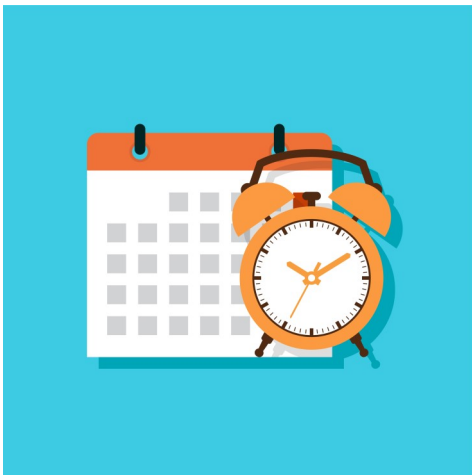

## ERNICA/EUPSA clinical exchange programme

This programme has been on hold due to the COVID-19 pandemic and is expected to resume as of September 2021.

Pediatric Surgery fellows and consultants from centres in the EU (both within and outside of ERNICA) can apply for a travel grant to visit an ERNICA centre for clinical training purposes (1 day—2 weeks). The programme is accredited by EUPSA.

## ERNICA/EU clinical exchange programme

The European Commission has granted ERNICA the possibility to use 34 clinical exchange packages until August 2022. This programme will be rolled-out in the coming months. Each package is up to 5 working days long and applications will be open to individuals from all full ERNICA member and affiliated partner hospitals. We would like to particularly invite non-surgical disciplines to apply (e.g. psychologists, nurses, physiotherapists, dieticians). ## CALL FOR CPMS CASES!

Since the last ERNICA general meeting in April 2021, a pilot implementation plan for the CPMS has been rolled out. Four groups of experts have been defined and a planned rota for bi-monthly discussions has been created. All healthcare providers are invited to propose cases for discussion.

The case discussions we have had so far on the CPMS have been successful but the number of cases proposed for discussion have been less than anticipated. We are confident that ERNICA can facilitate more case discussions to support more patients and healthcare professionals across Europe.

## RECENT PUBLICATIONS: CDH TOTAL TRIAL



The Tracheal Occlusion to Accelerate Lung Growth (TOTAL) trial led by Professor Jan Deprest from UZ Leuven has recently been completed and results relevant to unborn babies with moderate and severe congenital diaphragmatic hernia (CDH) have been published in The New England Journal Of Medicine.
